

Volunteer Position Description:

High Adventure Programming Volunteer

Purpose: To serve as a hands-on educator for girls interested in participating in High Adventure activities.

Commitment To:

• Girl Members

• GSCB

Duration: This position may be renewed annually contingent upon the timely maintenance of certifications in: CPR First Aid (Advanced or Wilderness required, if appropriate), High Ropes and Zipline, Small Craft, Archery, Target Sports, and any other certifications deemed necessary based on the ongoing interest areas and program offerings.

Responsibilities & Duties:

- Create opportunities for girls to participate in high adventure activities
- Support Girl Scouts in their ongoing development of their confidence in seeking outdoor challenges and high adventure activities
- Provide education and feedback to girls as they learn the skills required for their activities
- Provide opportunities for Junior Facilitators to support activities
- Encourage the adherence of Leave No Trace.
- Be a steward in the protection and preservation of GSCB property and the environment.
- Promote safe camping and outdoor activities through use of Safety Activity Checkpoints and Camping Guidelines.
- Follow all processes and procedures, as directed by Girl Scouts of the USA and Girl Scouts of the Chesapeake Bay.
- Complete property reservations, float plans, and travel applications as appropriate.
- Promote participation in high adventure activities to girl and adult members
- Work with Director of Program and Partnerships to refer new program partner opportunities for activities requiring professional support including, but not limited to: indoor skydiving, firearm safety and instruction, white water rafting, rock climbing, wind surfing, sailing, skiing, and other activities deemed high risk in <u>Safety Activity Checkpoints</u>

Training Requirements:

- Complete the 200 Outdoor Skills hybrid training with virtual components in gsLearn and in-person training with an Outdoor Skills Instructor.
- Complete the education required for Archery, High Ropes and Zipline, Small Craft, and Target Sports facilitators

General Requirements:

- Current membership with Girl Scouts of the Chesapeake Bay.
- Successfully completed the volunteer screening process, including background checks, training, and additional steps, as necessary.
- Participate in on going Girl Scout learning and networking opportunities.
- Maintain confidentiality.
- Access, ability, and willingness to utilize technology, including an active email address.
- Behave in a manner that upholds the Girl Scout Promise & Law in all interactions with the public, Girl Scout members, and GSCB staff.
- Provide the requested feedback surrounding all aspects of Girl Scouting.
