GIRL SCOUTS OF THE CHESAPEAKE BAY COUNCIL, INC. 2023 ANNUAL COUNCIL MEETING MINUTES

Volunteer Lyn Gill opened the business meeting by sharing information about the Girl Scout World Centres.

Board Chair Katya Nieburg-Wheeler welcomed in-person and virtual attendees to the 61st Annual Meeting of the Girl Scouts of the Chesapeake Bay Council. Katya stated quorum has been met with 48.6% of voting members present and called the meeting to order at 6:36 P.M. (approximately).

I. <u>Agenda approval:</u>

Katya asked for a motion to accept the 2023 Annual Meeting Agenda. The motion was moved and seconded. Motion carried unanimously.

II. Introduction of the Board of Directors

III. <u>Approval of 2022 Annual Meeting Minutes</u>

Katya asked for a motion to accept the 2022 Annual Meeting Minutes. The motion was moved and seconded. Motion carried unanimously.

IV. <u>Approval of Jan 19th Special Meeting Minutes</u>

Katya asked for a motion to accept the Jan 19th Special Meeting Minutes. The motion was moved and seconded. Motion carried unanimously.

V. <u>Treasurers Report</u>

Board Treasurer Dale Hoops presented the Treasurer's report capturing financial highlights of the year, including sources of revenue. Key points in the report included a report of a deficit of approximately 1 million as a result of a decrease in investment income. Also reported was non-sustainable source of income such as PPP loan forgiveness and employee retention grant. Dale clarified for the audience that "membership expense" is what we pay GSUSA in membership fees.

Katya asked for a motion to accept the Treasurer's Report. The motion was moved and seconded. Motion was carried by majority vote.

VI. <u>State of the Council Report</u>

Claudia Pena Porretti presented the State of the Council report which included a favorable year over year membership retention rate (the first time we have seen an increase since 2009), increased transparency with membership and additional opportunities for member feedback, new and improved girl programs, 300 highest awards earned, and meeting our product program goals. Also mentioned was the response to last year's property decision

and its impact on our movement. Praise was given for Peninsula Day of Service 2023 and the volunteers who helped plan and execute a great event. Claudia gave additional thanks to all volunteers and their continued commitment and recognized GSCB staff members.

VII. <u>Rules of Debate and Voting</u>

Katya asked for a motion to accept the rules of debate. The motion was moved and seconded. Motion carried unanimously.

VIII. <u>Amended Bylaws</u>

Katya reported that according to Section 1, Article XV, of our bylaws state that Bylaws may be amended by a two-thirds vote of those present in person (or linked by telecommunication or by means such that all members participating in the meeting are able to hear one another and participate in the proceedings) and voting at a meeting of the Council.

Katya asked if there was any debate. Katya heard no debate.

Katya asked for a motion to accept the Amended Bylaws. The motion was moved and seconded.
