# GIRL SCOUTS OF THE CHESAPEAKE BAY COUNCIL, INC. 2024 ANNUAL COUNCIL MEETING MINUTES

#### 5:30 P.M. (approximately)

Temeka Easter Rice, Board Chair, welcomed attendees. Girl Scouts Kaitlyn Williams, Abigail Malinky, Kaitlyn Malinky, Markella Coates, and Madison Snow led a flag ceremony. Lauralee Rappleye, Chair of the Annual Meeting Committee, gave opening remarks and explained instructions for building centerpieces reflecting the theme of the evening. Tiffanie Chandler led Grace.

Claudia Pena Porretti, CEO, began the meeting by sharing news about easement at Camp Country Center, which will allow GSCB to make much needed repairs and renovations. It will also allow the camp the remain a "green space" and camp property in perpetuity. More news hopefully to be shared in May Communications with Claudia email.

In the interest of transparency, Claudia also shared news about Camp Grove Point and meeting with Eastern Shore Land Conservancy. Claudia assures membership this is the best outcome we could hope for because it will allow the property to remain a "green space" but will hopefully allow for limited usage for Girl Scout members. Claudia read from an email from the Eastern Shore Land Conservancy, which detailed that the purpose of proposed acquisition is to protect and enhance wildlife habitat and eventually provide public land access for recreation and water access. We are currently in the due diligence stage, which can take up to 8 months or more. Claudia has stated she will keep membership informed of any progress.

Claudia shared that the above property decisions will put us in the best financial position to serve our girls.

Claudia asked attendees to keep the camp property information as confidential as possible, and shares her sincere gratitude for volunteers.

Board Chair Temeka Easter Rice welcomed in-person and virtual attendees to the 62<sup>nd</sup> Annual Meeting of the Girl Scouts of the Chesapeake Bay Council, and notified attendees that the meeting will be recorded and transcribed. Temeka recognized Archives Committee, Annual Meeting Committee, Board Development Committee, Recognitions Committee, Finance Committee, Property Committee, and Advancement Committee. Temeka recognized lifetime members, teen board members, and Girl Scouts who performed the flag ceremony. A moment of silence was held for members lost in the past year, as well as those who perished in the Francis Scott Key bridge collapse. Temeka stated quorum has been met with 41.4% of voting members present and called the meeting to order at 6:52 P.M. (approximately).

#### II. Introduction of the Board of Directors

## III. <u>Approval of 2023 Annual Meeting Minutes</u>

Temeka asked for a motion to accept the 2023 Annual Meeting Minutes. The motion was moved and seconded. Motion carried unanimously.

## IV. <u>Treasurers Report</u>

Interim Board Treasurer Janet Chavous presented the Treasurer's report capturing financial highlights of the year, including sources of revenue. Key points in the report included a report that Product Programs are the largest generator of revenue, Programming makes up the largest expense, and a total deficit of approximately \$656,000. Also reported was non-sustainable source of income such as employee retention grant resulting from the pandemic.

## V. <u>State of the Council Report</u>

Claudia Pena Porretti presented the State of the Council report which included a a second consecutive year of favorable year over year membership retention rate, successful girl programs, 155 highest awards earned, and favorable year over year rates for many of our Product Program benchmarks. Claudia gave additional thanks to all volunteers and their continued commitment and recognized GSCB staff members.

Claudia addresses the loss of Camp Grove Point, shares personal experience of loss.

#### VI. <u>National Council Session Debrief</u>

National Delegates Heather Burket and Ellie Davis report out on their experience at the Girl Scout National Convention held in Orlando, FL in July 2023. Highlights shared by Heather included election of new National Board, new National President, discussion and debate of proposals. Proposals included timing of delegate allotment (approved), amendment for allowing virtual attendance of national council sessions and regular sessions of the national council (divided approval), creation of donor-restricted fund in support of Gold Award scholarships (approved), representation of councils on the national board (defeated), creation of a formula for delegates (defeated), amendment to change DEIRJ Language in the constitution (approved), amendment of the language of the Girl Scout Promise and Law (defeated).

Ellie Davis gave her impressions of the experience – she left feeling determined. She also renewed as a Lifetime Member. Ellie encouraged all members to attend the next National Council Session and Convention in Washington D.C. in 2026.

Heather shared her impressions of the experience – she left feeling invigorated. She asked members to save the date for the 2026 Convention.
